Biography—Hal & Sue Rosenthal

"Four children, their spouses, six grandchildren and our love, legally initiated by marriage June 20, 1954 which grows lovelier each day. To us, that is what matters." - Hal & Sue Rosenthal



Sue is a retired Philadelphia public high school teacher; Hal, a practicing attorney who at the age of 16 lied to join and spend four years in the Naval Reserves.

Upon completing Law School, 1955, Hal was drafted into the Navy. At Bainbridge, Maryland boot camp, an officer noting the four years' Naval Reserve time, ordered Hal to wear a gold stripe despite his then only being an SN. Not wanting to be razzed by other boots for four years good conduct and no promotion, Hal

sewed the stripe on for morning quarters tearing it off as soon as the officer left for the day.

The first duty station was Brunswick, Maine NAS where Hal served as a Legal Yeoman. Sue and Hal lived in Navy housing designed for Jacksonville, Florida NAS and whose plans had accidently been sent to Brunswick. At Maine temperatures, sometimes -30, they burned a ton of coal every two weeks and still had up to an inch of ice on the inside of window glass. Hal's duties included preparing papers for Captain's Masts, Court Marshalls, representing sailors at civilian traffic courts, preparing wills for them and advising on other legal matters.

To counter civilian stores increasing prices during every pay day period, Hal obtained permission to pay sailors and base civilians with two dollar bills. After three pay days, banks and stores up to forty miles away pleaded to stop the glut of the seldom seen legal tender. How many two dollar bills do you have in your pocket? The compromise was sailors showing ID were given a 10% discount.

After a year Hal was transferred to our Johnson, then Home Port, Newport, Road Island. Being the eighth assigned to the four seat Ship's Office, caused Hal to spend most of his time aboard wandering through the ship, and reading, watching the sea, the sky and the Turkey Tail from the fantail.

Sue who taught on an island in Narragansett Bay had more sea time then Hal until the Jolly J shoved off for a four month Med cruise during which Hal's duties included Captain's Talker. Hal's two year stint ended in 1957 with helping to produce the Cruise Book.

Hal and Sue greatly honor those who served more than his two years, particularly those who served during war times.

THE CITY OF BROTHERLY LOVE WELCOMES THE 2015 USS JOHNSTON DD-821 REUNION

The destination for the 23rd annual USS Johnston DD-821 reunion was, as in past years, chosen by a majority of shipmates at the 2014 reunion. The city was Philadelphia and it was chosen over Baltimore and Williamsburg.

Our struggle for freedom as well as the beginning of our government have their roots in this city. It is truly the birthplace of our Nation. There is so much history and there are so many worthwhile sites that the four days of our reunion were too short to experience the full offering of this amazing city.

The Hilton Garden Inn was the perfect location to hold the reunion as it was in the center of the downtown and within walking distance of many historical attractions such as Independence Hall, the Liberty Bell, the Federal Reserve and the U.S. Mint just to name a few.

Before I continue the story of our reunion, however, I want to briefly tell you about our reunion warm up. Ten of us signed up for the Bermuda cruise aboard the beautiful cruise ship, Celebrity Summit. It was arranged by John and Donna Argonti, a shipmate and his wife who own a travel agency. The cruise experience and Bermuda (a British colony with its own rich history) were fantastic. The crew was terrific, the food was delicious, and Bermuda was extraordinarily beautiful. The cruise was my 15th and I must say that Bermuda ranks in the top three of my favorite islands. Unlike most Caribbean Islands, I did not see evidence of poverty, panhandling, or folks pestering you to buy their wares. Crime is very low and we felt very safe and comfortable walking around the town. This is one island where I would happily vacation and not be overly concerned about safety. (Of course, security matters change quickly so that travelers must always be on their guard.) The only drawback for Bermuda is the high cost of living. The median price of a home is \$1.5M. So, it is definitely a grand vacation destination but, in my opinion, not a place for permanent residency for most of us.

On the ship, we ate sumptuous meals, enjoyed entertaining shows, played cards and laughed into the late night as we cruised the Atlantic Ocean. This was definitely not a cruise on the U.S.S. Johnston DD-821 except that we used the standard Naval terminology – the head, port, starboard, forward, aft, bulkhead, deck, etc. All of us agreed that it was a great way to get to know each other and develop a lasting bond much like the shipmates of the U.S.S. Johnston DD-821 had done in past generations.

Well, back in Philly on Monday, May 17th, the attendees started trickling into the Hospitality Room and the shouts and greetings of the shipmates could be heard all the way down the hall. They were glad to be reunited again and some were already pulling out their photo albums to once again relive the good memories and comfort each other on other experiences.

The camaraderie continued into the evening with cocktails and the Welcome Dinner. The chef and his staff prepared an exceptional meal that included an entree of chicken with wild

mushrooms and bourbon demi-glaze as well as seared salmon with Caribbean mango sauce.

A professional photographer had offered to come to the reunion to take group and individual pictures as a way of giving back to our brave sailors who served our country. The photographer and assistant traveled at their own expense and only charged a nominal amount to cover costs if anyone wanted to purchase photographs.

On Tuesday morning, we climbed into a tour bus for a 4-hour tour of Philadelphia. Among the most notable stops were Independence Hall where both the Declaration of Independence and the Constitution were signed, the Liberty Bell, and Christ Church and burial grounds. George Washington and Betsy Ross attended Christ Church and William Penn was baptized here. In the burial grounds are seven signers of the Constitution including Ben Franklin. As I walked these sites, I experienced so many emotions - joy, pride, humility, awe, inspiration. Above all, I was overwhelmed with gratitude that, as an Italian immigrant, I was able to come to the greatest nation on earth, work hard and achieve my goals. It had all been possible because of the determination and sacrifices of the people that toiled in those buildings to form this Nation and to all the brave veterans that preserved our freedom since that time.

Our last stop was not so much historical as entertaining. We were at the Philadelphia Museum of Art where we retraced the climb of Rocky Balboa up the 72 steps that were made famous by the Rocky movies. The only thing that was missing was the song in those movies, "Gonna Fly Now".

Wednesday was a full day of touring, stopping first at Valley Forge and visiting the house that George Washington used as his headquarters the winter of 1777-78. The modest home served as his office and sleeping quarters. We also climbed the steep steps up to the third floor where his security force was housed. On the perimeter of Valley Forge, we got a close view of the huts where the soldiers were encamped. The huts provided a glimpse of the miserable living conditions those men endured so that they might win freedom for future generations. I reflected on the bravery of the men and women in our military who are doing the very same thing today in many parts of the world.

Back on the road, we saw the National Memorial Arch which is very prominent in Valley Forge standing at 60' high. A brief stop at the Washington Memorial Chapel, an Episcopal church built as a tribute to George Washington and the patriots of the Revolution, ended the morning tour and we headed to Camden, New Jersey for the tour of U.S.S. New Jersey.

By the time we arrived at the port, we were hungry and welcomed the box lunch the Association provided for us before starting our tour. The U.S.S. New Jersey is the most decorated Navy ship of all time. At 45,000 tons and almost three football fields long, this battleship had roles in World War II, Korea, Vietnam, and the Persian Gulf wars. Our tour guide, George, himself a former sailor on the U.S.S. New Jersey, guided us throughout the vessel, including the Bridge, Captain's cabin, Officer's Wardroom, sailor's quarters, and communications area. Climbing up and down the companionways was exhausting but we were fortified by a substantial lunch and were enthralled by George's knowledge of the ship and the passion with which he conveyed the information. The time flew by and we were surprised that we had spent several hours on the ship and it was time to disembark.

Thursday, May 21st was a free day until the 4 p.m. business meeting. Some of us decided to venture out on our own. The following were among the most desirable to visit:

- * The Betsy Ross House
- * City Hall a magnificent building started in 1870 and finished in 1901 along with the statue of William Penn that sits on top it and is the tallest statue on a building in the world.
- * The thousands of murals in Philadelphia. It is the mural capital of the world.
- * The U.S. Mint
- * The Federal Reserve Building
- * The Philadelphia Museum of Art
- * Reading Terminal Market, one of America's largest and oldest public markets, where the dining choices are endless and the selection of goods extends to local and international products.

The afternoon was coming to a close and we rushed back for the business meeting and Farewell Banquet. The Banquet opened with a prayer and the Missing Man Ceremony, a solemn reminder that we will never forget the soldiers left behind on the battle fields of foreign lands. We will always honor their service, their sacrifice, and will always work to bring them home.

After the superb meal, we honored Mike and Regina Persiano with a cake and a "Happy Anniversary" song on their 65th wedding anniversary. They were thrilled and we were happy to be able to help them celebrate this special occasion. The last event was our White Elephant Auction which is always fun as we raffle off items that the attendees have contributed. I won a book, oven mitts, and (my favorite) earbuds for my phone enclosed in a small blue bag with a U.S. Navy logo.

In the hospitality room after the banquet, it was time for final good-byes. Some exchanged emails and phone numbers as they committed to seeing their shipmates in 2016 in St. Augustine/Jacksonville, Florida.

2016 Johnston Association Reunion is the 25th Anniversary of our Reunions!

The 2016 USS Johnston DD-821 Reunion will be held in Jacksonville, Florida. We have arranged our hotel arrangements at the five-million dollar newly renovated Double Tree Jacksonville Riverfront Hotel located at 1201 Riverplace Blvd, Jacksonville, FL 32207. It is located downtown on the Riverwalk and convenient to restaurants and the newly docked museum ship USS Charles F. Adams DDG2.

Due to Jacksonville being the home to so many conventions in May, the Johnston reunion has been moved up to Monday, April 4th thru the evening of April 7th. To be able to attend the entire reunion, you should arrive no later than Monday the 4th and leave no earlier than Friday the 8th as a minimum. Come earlier or stay later if you wish.








Wake Up Call

I find it interesting to know what my former shipmates have been doing in their lives all these years since I served on the Jolly J. Your story can be a few paragraphs to a page or more. Secondly we would appreciate payment of the yearly dues if at all possible. We do understand that not all can afford to pay and that is OK. However at \$15/year, you have to admit it's a great deal. At the time of this writing, we have only 85 paying members for 2015 or beyond out of the 376 (23%) that are currently listed on our roster. All shipmates on the roster receive our newsletters and have been sent a dues payment form. The dues basically keep the Association afloat by not only paying for the printing of the newsletters but the cost of mailing them also. Dues also help to defray the costs of maintaining the USS Johnston website (www.ussjohnston.org). Now I don't know about you, but in my opinion, our website is second to none. You do the math, each mailing of the newsletter cost about \$350 time 80 paying members equals \$1200. That barely covers the cost of three mailings let alone four and doesn't leave a dime for our website. Extra donations have been our saving grace. Keep in mind the dues are NOT tax deductible!
